**U.S. AND JAPANESE WOMEN PUBLIC SECTOR LEADERS TO EXPLORE SOCIAL  
POLICY ISSUES DURING NEW EXCHANGE PROGRAM**

WASHINGTON, D.C. A select group of seven U.S. women leaders—all prominent elected officials or public sector leaders—will travel to Japan December 4-12, 2004, to explore with their Japanese counterparts common social policy issues and how they are addressed in their respective nations. This first-of-its-kind, weeklong exchange, which includes meetings, seminars and conferences in three Japanese cities, has been organized by the Maureen and Mike Mansfield Foundation and the National Association of Japan-America Societies with sponsorship by Citigroup. All Nippon Airways provided in-kind support for airline tickets for the delegation. A second exchange, during which a delegation of Japanese women leaders will visit the United States, will take place in spring 2005.
